These standards align with and are supported by NAEYC's documents and position statements and stand on Michigan's more than 50-year tradition of national leadership in the early childhood field.

We stand behind the principles of DAP, including Diversity, Equity, and Inclusion. Equitability ensures resources are distributed based on need so that all can participate fairly. All children have the right to equitable learning opportunities that help them achieve their full potential as engaged learners and valued members of society, which includes diverse educators. We support initiatives that embrace diversity and full inclusion as strengths, promote anti-bias education, uphold fundamental principles of fairness and justice, and work to eliminate structural inequities that limit equitable learning opportunities.

We trust the expertise and experiences of early childhood educators working with families to ensure young children can learn and thrive in our diverse world. And we bring our voices together to provide clarity and support for our continued, collective work to ensure that all young children can access high-quality, developmentally appropriate early learning experiences across all states, settings, and communities.
